Last Will and Testament

THIS WILL is made by me REGINALD FRANK HAYNES of Woodland Thatch 54 Mount Avenue Hutton Mount Brentwood Essex CM13 2PB

1. **Revocation**

I revoke all earlier Wills and testamentary dispositions.

2. **Appointment of Executors**

2.1 I appoint my daughter Jenifer Anne Diva of 9 Beech Wood Close, West Marton, North Yorkshire, BD23 3UG and my daughter Alison Patricia Burkert of Greensted Cottage, Greensted, Essex, CM5 0LB to be my executrices and trustees.

2.2 The expression "**my Trustees**" means my personal representatives and the trustees of this Will and of any trust that might arise under it.

3. **Money Bequests**

I make the following gifts of money:-

3.1 I give to my daughter Jenifer Anne Diva free of all taxes the sum of £425,000 pounds.

3.2 I give to my daughter Alison Patricia Burkert free of all taxes the sum of £425,000 pounds.

3.3 I give to my grandson Jason Butler of 28 Albermarle Gardens, Braintree, Essex, CM7 9UQ free of all taxes the sum of £15,000 pounds.

3.4 I give to my grandson Darren Butler of 23B Crown Street, Brentwood, Essex, CM14 4BA free of all taxes the sum of £15,000 pounds.

3.5 I give to my grandson Martin Burkert of 63 High Avenue, Letchworth Garden City, Hertfordshire, SG6 3QR free of all taxes the sum of £15,000 pounds.

3.6 I give to my granddaughter Gemma Gilbey of 33 Court One, Bronte Road, Witham, Essex, CM8 2QG free of all taxes the sum of £15,000 pounds.

3.7 I give to my niece Adrienne Hollingsworth of Baytree Cottage, Bayford Green, Bayford, Hertfordshire, SG13 8PU free of all taxes the sum of £1,000 pounds.

3.8 I give to my niece Elaine Comet free of all taxes the sum of £1,000 pounds.

3.9 I give to my niece Christine Lovett free of all taxes the sum of £1,000 pounds.

3.10 I give to Nicholas Glen Butler free of all taxes the sum of £500 pounds.

3.11 I give to my niece Teresa Moore of 54 Meadow Walk, Henlow, Bedfordshire, SG16 6HJ free of all taxes the sum of £1,000 pounds.

- 3.12 I give to my niece Cathy Dunn of 25 Rosemary Close, Peacehaven, BN10 8BY free of all taxes the sum of £1,000 pounds.
- 3.13 I give to Debbie Haynes of Unit 4 Washington Street, Essenden, Melbourne, 3000 Australia free of all taxes the sum of £500 pounds.
- 3.14 I give to Nicholas Hollingsworth of Peter Hayes Farm, Forde Street, Wellington, Somerset, TA21 9PE free of all taxes the sum of £500 pounds.
- 3.15 I give to Jeremy Hollingsworth of 138 Station Road, Harpenden, Hertfordshire, AL5 4RH free of all taxes the sum of £500 pounds.
- 3.16 I give to Claire Gee of 3 Ermine Street, Thundridge, Hertfordshire, SG12 0SZ free of all taxes the sum of £500 pounds.
- 3.17 I give to Dave Johnson free of all taxes the sum of £500 pounds subject to him still being employed as my gardener at the time of my death.

4. **Definition of my Estate**

In my Will where the context so admits "**my Estate**" shall mean:

- 4.1 All my property of every kind wherever situated.
- 4.2 All my property of every kind wherever situated over which I have a general power of appointment.
- 4.3 The money investments and property from time to time representing all such property.

5. **Administration of my Estate**

My Trustees shall hold the residue of my Estate upon trust to retain postpone or sell it and will:

- 5.1 Pay any debts funeral and testamentary expenses.
- 5.2 Pay all the gifts of money referred to in my Will.
- 5.3 Deal with the remainder ("my Residuary Estate") as I now direct.

6. **Gifts of Residue**

Subject as above my Trustees shall hold my Residuary Estate as follows:-

- 6.1 As to a 50 % share of residue to my daughter Jenifer Anne Diva absolutely and if Jenifer Anne Diva shall fail to obtain a vested interest leaving issue who survive me then such issue shall take by substitution and if there shall be more than one of such issue they shall take in equal shares per stirpes but so that no issue shall take whose parent is alive and so capable of taking.
- 6.2 As to a 50 % share of residue to my daughter Alison Patricia Burkert absolutely and if Alison Patricia Burkert shall fail to obtain a vested interest leaving issue who survive me then such issue shall take by substitution and if there shall be more than one of such issue they shall take in equal shares per stirpes but so that no issue shall take whose parent is

alive and so capable of taking.

6.3 If under this clause any share fails such share shall return to my Residuary Estate and be distributed to the other beneficiaries pro rata according to their shares.

7. **Declaration Excluding Section 33 of the Wills Act 1837**

Section 33 of the Wills Act 1837 (as substituted by section 19 of the Administration of Justice Act 1982) shall not apply to any of the foregoing trusts.

8. **Standard Provisions**

The Standard Provisions and all of the Special Provisions of the Society of Trust and Estate Practitioners (2nd Edition) shall apply.
